THE COMPLETE BALANCE FOR YOUR WEDDING PARTY, WITH THE EXCEPTION OF HAIR APPOINTMENTS, WILL BE DUE IN FULL 30 DAYS BEFORE YOUR WEDDING DATE APPOINTMENTS TO AVOID CONFUSION ON YOUR WEDDING DAY. YOU WILL BE PROVIDED WITH A BILL IN ADVANCE. PAYMENT FOR HAIR APPOINTMENTS IS EXPECTED ON THE DAY OF YOUR WEDDING. PLEASE FEEL FREE TO CONTACT US AT ANY TIME WITH ANY QUESTIONS OR CONCERNS YOU MAY HAVE IN REGARD TO YOUR WEDDING APPOINTMENTS. - A CREDIT CARD IS REQUIRED TO RESERVE APPOINTMENTS, ALL MAJOR CREDIT CARDS ARE ACCEPTED.
- WE REQUIRE 30 DAYS NOTIFICATION TO CANCEL BRIDAL APPOINTMENTS.
- IF YOU CANCEL IN LESS THAN 30 DAYS WE CHARGE YOUR DEPOSIT CREDIT CARD FULL PRICE OF THE SERVICES BOOKED.
- NO SHOWS WILL BE CHARGED FULL AMOUNT FOR SCHEDULED APPOINTMENTS.
- DEPOSITS, PACKAGES AND GIFT CERTIFICATES ARE NON-REFUNDABLE AND MAY BE USED IN THE SPA FOR SERVICES OR PRODUCT IF BRIDAL APPOINTMENTS ARE CANCELLED WITHIN 30 DAYS BEFORE APPOINTMENTS.
- IF THE BRIDE'S PACKAGE IS PURCHASED, IT IS CONSIDERED A GIFT CERTIFICATE AND IS NOT REDEEMABLE FOR CASH OR REFUND IF APPOINTMENTS ARE CANCELLED. IF YOU HAVE THIS PACKAGE AND CANCEL YOUR APPOINTMENTS THE PACKAGE PRICES WILL BE ADJUSTED TO A LA CARTE VALUES.

### UPDOS

PLEASE DO NOT WASH YOUR HAIR THE DAY OF YOUR APPOINTMENT. FOR HAIR TO STAY UP EASILY IT MUST BE SOMEWHAT DIRTY. WE RECOMMEND THAT YOU WASH YOUR HAIR THE DAY PRIOR TO YOUR UPDO APPOINTMENT AND LET IT DRY NATURALLY. PLEASE DO NOT APPLY ANY PRODUCTS TO YOUR HAIR AT THIS TIME.

### BLOW OUTS/ STYLES

PLEASE COME IN WITH FRESHLY WASHED HAIR. DO NOT APPLY ANY PRODUCTS TO YOUR HAIR AFTER WASHING IT OR BLOW DRY/ STYLE IT IN ANY WAY.

### PAYMENT

PLEASE NOTE THAT ALL HAIR APPOINTMENTS CAN ONLY BE PAID FOR WITH CASH OR CHECK. WE REGRET THAT WE CANNOT ACCEPT CREDIT CARDS TO PAY FOR HAIR APPOINTMENTS. PAYMENT FOR HAIR APPOINTMENTS, OTHER THAN CONSULTATIONS, IS DUE ON THE DAY OF YOUR WEDDING.
